

B&E Personal Banking Insurance Competition

Terms & Conditions

General

1. By entering the competition, you agree to be bound by these terms and conditions.
2. This competition is conducted by B&E Ltd (trading as B&E Personal Banking), ABN 32 087 652 088 AFSL & Australian Credit Licence 236870.
3. Home, Contents, Motor Vehicle, Boat, Caravan, and Landlords Insurance products are issued by CGU Insurance Limited, ABN 27 004 478 371 AFSL No. 238291 (CGU). In offering these products, B&E acts under its own Australian Financial Services Licence and under agreement with the insurers, CGU.

Conditions of entry

1. This competition is open to Tasmanian residents aged 18 years or over, who purchase a new or renew an existing eligible CGU general insurance policy through B&E during the competition period.
